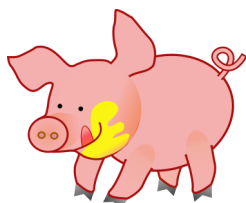
The boat parades were cancelled due to inclement weather.

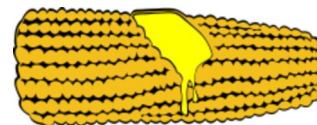

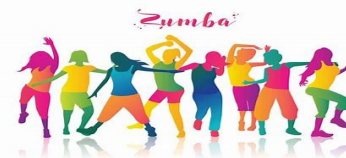

Road Safety

Even though the topic of safety on our roadways was not an agenda item, it happened to be discussed at the October and November monthly TLCC board meetings. Several residents have expressed concerns regarding several near-miss encounters with small motorized vehicles such as scooters, mini-bikes and golf carts.

We have been very lucky that no serious injuries have occurred. Prioritizing road safety around the lakes can help prevent accidents from happening. Staying alert and cautious when sharing the road with other cars, smaller motorized vehicles and pedestrians will also decrease these chances.

Responsible riding is essential to avoid injuries as well as avoiding legal repercussions. A reckless rider is a risk to drivers, innocent bystanders and properties.

When sharing the road:

Follow the speed limit (35 mph max for Low Speed Vehicles on public roads) and other roadway regulations.

All drivers must have a valid driver's license.

Wear bright or reflective clothing for better visibility.

Be respectful to your neighbors.

The 2024 Fisharama Fundraiser will consist of both adult and children's divisions with the following fish categories:

*Pan Fish *Northern *Other Legal Fish

Adult division first place contestants will be awarded \$100.00 for the "longest LIVE fish" caught in each category. Children's division first place contestants will be awarded \$25.00 for the "longest LIVE fish" caught in each category.

In addition, all anglers will be eligible to win prizes in the "Fish Caught Drawing". With each registered fish, contestants will be entered into the drawing.

The fishing contest fee is \$10.00 for adults and \$5.00 for children under twelve years of age. As in the past, food and beverages will be available for purchase. Annual raffle tickets will be sold with "on the ice" drawings held every fifteen minutes starting at 12:15 P.M. Beginning at 4:30 the 50/50 raffle drawing and annual raffle ticket winners will be drawn, followed by the fishing contest winners.

TLCC volunteers will drill holes upon request for the contestants. In the event of adverse weather/ice conditions, the contest registration and prize drawings will take place at the boat landing on Amnicon Lake. In this case, there will be no parking available at the landing.

The annual Fisharama FUNDRAISER is an event that people look forward to each February. The TLCC wishes all fishing contestants good luck. We hope to see everyone on the ice!

Please keep in mind: the cost of the raffle tickets is separate from any fishing contest fees.

The raffle prizes will be as follows: 1st Place— \$500; 2nd Place—\$250; 3rd Place—\$100.

Amnicon-Dowling Lake Management District Update

Over the last few years we have welcomed a number of new property owners to our lakes and nearby areas. When talking to these new residents it has become apparent that many of them are unclear about the structure and function of the Lake Management District. This article hopes to clarify this issue.

The Amnicon Dowling Lake Management District is a specialized unit of government established to manage Amnicon and Dowling Lakes and their watersheds. It is organized under the Wisconsin State Statutes Chap. 33.

Our mission statement: The purpose of the Amnicon Dowling Lake Management District is to preserve and protect Amnicon and Dowling Lakes, their surroundings, watershed, and to enhance the water quality, fishery, boating safety and aesthetic values of both lakes as a public recreational facility for today and for future generations for the mutual good of our residents, public and the lake’s environment.

What it is: A governmental organization.

What it is not: A club or social organization.

What it is: Mandatory membership based on property ownership within the district boundaries.

What it is not: Voluntary membership by joining and paying membership dues.

What it can do: Levy taxes on properties within the district.

What it cannot do: Raise money by requiring dues or fundraising.

Some sanctioned activities: Monitor water quality, inventory and manage aquatic plant populations, purchase lands to protect sensitive areas, restore wetlands, provide educational opportunities, and develop and implement long-range lake management plans.

In 2021, ADLMD was awarded a comprehensive planning grant through the WI DNR. The purpose of this grant was to develop a ten (10) year strategic plan for the District that will serve as a roadmap for future District activities.

Seven goals were established, with specific prioritized objectives and activities associated with each goal.

The final report was submitted to the DNR in August, 2023 for approval, after review and input from the District’s stakeholders. We are still awaiting DNR approval. Once approved, the District will move forward to implement the plan. Active stakeholder participation is critical for the successful implementation of the plan (see goal seven). If not, the district will need to raise the tax levy to contract out the work.

Strategic Plan Goals

Shoreline and Near Shore Goal: Implement shoreline and near shore practices to improve the water quality and habitat of the lakes.

Educational Goal: Provide educational opportunities and information to Stakeholders and the public.

Fisheries Goal: Improve Quality of Fisheries & Fisheries Habitat of the lakes.

Recreation Goal: Oversight of Recreational Usage of Amnicon and Dowling Lakes to ensure a safe and healthy multipurpose recreational environment.

Aquatic Plants Goal: Manage and Control both Native and Invasive Aquatic Plants.

Water Quality Goal: Reduce external and internal nutrient loading in both lakes and in their watersheds to achieve a water quality that will support a healthy lake ecosystem.

Plan Implementation and Amendment Goal: Follow through with the implementation of the plan. Review yearly and amend if necessary.
